3. The number of your **FAA sUAS Registration valid for 2025**, – optional (\*\*)

(\*) MASM office will validate current AMA license via AMA website. Full, Three-month Trial, or Youth AMA membership is required (Park Pilot membership is not satisfactory).

(\*\*) Applicant without current (2025) AMA license or FAA sUAS Registration will be classified as Social Member (no Field Pass and no Flying Privileges).

*(“Social Members shall have all rights and privileges of membership except the right to operate and fly a model at the flying field”).*
