Dean said that there were 25 people at the October meeting and that there were two membership renewals last month, bringing the member total to 212 members.

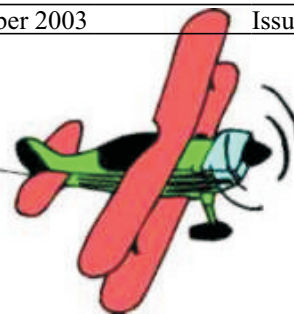
Treasurer's report
